Regarding Sufficiency of Dissolution Petition Filed July 1, 2021

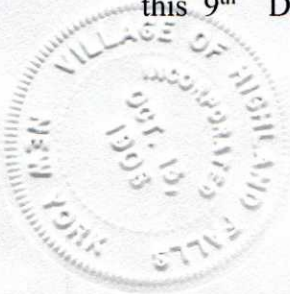
The undersigned Village Clerk of the Village of Highland Falls DOES HEREBY CERTIFY:

Dear Mr. DeWitt,

This letter is to notify you that I have reviewed the petition to dissolve the Village of Highland Falls and I have found it to be a valid petition. The law requires 10% of the registered voters to sign the petition and upon review 402 signatures were submitted and 346 were deemed to be valid registered voters. The Village of Highland Falls has 2388 registered voters therefore this petition has exceeded the required minimum number of signatures needed.

The Village Board has thirty days in which to meet for the purpose of setting a referendum date. Notifications will be published in the News of the Highlands and on the Village website, www.highlandfallsny.org once this date has been determined.
