# NEW PALTZ CONSOLIDATION: DETAILED 2026 SCHEDULE

This document details the Town and Village consolidation schedule, including meetings and key decision points.

## Critical Context: Public Discussion of Consolidation

To facilitate robust public discussion, the New Paltz Town and Village Boards have added consolidation as a standing item on all monthly meeting agendas. Representatives of the joint consolidation working group — Mayor Alex Wojcik for the Village, and Supervisor Tim Rogers and Councilwoman Lauren McPadden for the Town — will regularly report on progress, take questions, and receive public feedback. All meetings can be attended in person or viewed on YouTube.

## Meeting Schedule

Town Board meetings will be held on April 9, May 7, June 4, and July 2 at the Courthouse, 59 N. Putt Corners Road. Village Board meetings will be held on April 1, May 6, June 3, and July 1 at Village Hall. Both boards will also convene monthly joint meetings where consolidation will be a standing agenda item: April 22, May 20, June 17, July 15, and August 5 at Village Hall. Public comments can be offered at all of these meetings.

In early May, the *draft* consolidation agreement will be released. A Joint Workshop on May 21 at Village Hall will be devoted exclusively to consolidation. On June 1, both boards will vote on whether to send the draft agreement to a public hearing. Public hearings are scheduled for June 17, July 7, July 15, and July 29, all at Village Hall except July 7, which will be held at the Middle School, 196 Main Street.

On July 15, both boards will vote on whether to finalize the agreement. On August 5, they will vote on whether to send the consolidation referendum to voters. Final passage requires separate majorities from Village voters and Town Outside Village (TOV) voters on Election Day in November.
